Der **Mummelsee** ist ein Karsee im Schwarzwald. Er ist 3,7 Hektar groß, 17 Meter tief und liegt auf 1036 m ü. NN. Er befindet sich in der Gemeinde Seebach in der Nähe von Achern im nördlichen Schwarzwald.

Der See zählt zu den meistbesuchten Seen in Baden-Württemberg, da er direkt an der Schwarzwaldhochstraße liegt.

Er ist im Westen, Norden und Osten von steilen, bewaldeten Berghängen gesäumt und hat einen Umfang von etwa 800 Metern. Nach Westen steigt das Seeufer zum „*Katzenkopf*“ (1123 Meter) und nach Norden zur Hornisgrinde an, dem mit 1164 Meter höchsten Berg des Nordschwarzwaldes. Lediglich nach Süden sind die Ufer des Mummelsees (fast) flach, dort liegt unter anderem ein Hotel.

Der Name des Mummelsees geht nach Angaben der Gemeinde Seebach zurück auf die weißen Seerosen, im Volksmund „Mummeln“ genannt, die hier früher zahlreich vorkamen<sup>[2]</sup>. Allerdings bezeichnet in der Botanik „Mummel“ die Gelbe Teichrose (*Nuphar lutea*).

## Gastronomie und Gewerbe

Begünstigt durch den Verlauf der weit bekannten Schwarzwaldhochstraße wurde der See auch für den Tourismus interessant. Ein größeres Gebäude mit Hotel, zwei Restaurants, ein Lebensmittel- und Souvenirladen sowie ein Tretbootverleih befinden sich direkt neben dem großen Besucherparkplatz. Gleich anschließend befindet sich ein Einkaufsgebäude, in dem Souvenirs und hausgemachte Schwarzwälder Lebensmittel wie Schinken, Wurst und Käse erstanden werden können. Mehrmals täglich wird hier per Holzfeuerofen traditionelles Holzofenbrot gebacken.

Das Hotelgebäude wurde am 5. Mai 2008 durch ein Feuer zum großen Teil zerstört.<sup>[3]</sup> Ursache ist vermutlich fahrlässige Brandstiftung.<sup>[4]</sup> Das Hotel wurde nach dem Brand im Schwarzwaldstil wieder aufgebaut und am 26. März 2010 eröffnet, die Nutzfläche erhöhte sich von 2385 Quadratmeter auf 3690 Quadratmeter.

## Der Mummelsee in der Literatur

- Um den einst noch ohne Straßenverbindung in tiefer Einsamkeit liegenden See ranken sich etliche Sagen. Einer Sage nach lebte in dem See eine Nixe, welche den Menschen nachts Hilfe gewährte und mit ihnen tanzte, sang und spielte.
- Die Sagen inspirierten Eduard Mörike zu seinem Gedicht *Die Geister am Mummelsee*.
- Grimmelshausen ließ seinen Simplicissimus in den See tauchen und dessen angeblichen Bewohnern begegnen.

## Kunstpfad

Auf dem „Kunstpfad“ rund um den Mummelsee sind Kunstwerke von modernen Künstlern installiert und in die Natur eingebunden.

## Verkehrsanbindung

Parkplätze für die Besucher des Sees liegen am Südufer. Mit öffentlichen Verkehrsmitteln gibt es tägliche Verbindungen mit Wanderbussen von Baden-Baden und Achern, in denen Baden-Württemberg-Ticket und Schönes-Wochenende-Ticket anerkannt sind.



## 0. PREAMBLE
